2- Our staff at the Plant almost completed 10 days on duty, and they are very disturbed and worried because they feel they are like prisoners inside the plant, and they are worried upon their families status, and we can not replace the current staff at the Plant with fresh one, because the PYD is seizing control of the plant entrance and not allowing anybody to enter or exit from the plant, also we are as management here in Syria, and under the current vague circumstances, are unable to reassure our employees regarding when and how this situation will end, since we can not predict the next developments in situations around the plant ,

We need your kind help to settle this issue with our neighbors , and allowing us of replacing our staff, and enter or exit the plant without complexities from their side.
