dear all

first I am very sorry for this long email plant evacuation and my situation after ten days please FKYI and now I can write this email to explain what happened with me on 18th of September and after : before one week and since the clashes started surround our plant .daily I follow up the situation during the night with two persons one in the east side from gog taba village 5 KM from the plant his name abu Faisal and one in the north side from Aljalapia village 5 KM from the plant his name Dago and both of them have good relation with PYD and we also followup from upside the preheater and CCR building , on 18th of September 05:00 AM early both of them contacted with me and they told me to take care because the situation out side the plant deteriorated and maybe Islamic state will reach to the plant anytime during few hours .then I take decision to evacuate my family to the private quarry Alshba west the the plant 5 KM as the first step and we agreed before one week during conf,call for this step and the next step will be to ean alarab or to safe area .also I take decision to stop the CPP immediately (I know psycho case for my team in the plant ,if they heard this news or any military person enter to the plant I am sure they will let all equipment's running and leave the plant) . I told you all these news during conf.call on 18th September at 09:00 AM also during conf,call Ali came to me and he asked me to till you the plant in danger case and I mentioned this during conf.call .

at 03:00 PM one person his name Mohamad Aljasm in tall abiad told me Mr Hassan don't worry Islamic state will come to the plant during short time but they asked me if you still in the plant and I told them he is good man and they answered we know (I think in that moment he is liar and I didn't take any care for his news)

at 05: 00 PM one person his name soltan he told me same news which I received from Aljasm before two hours and he told me I am in Alraqa now (he was before one year patroller in the plant and we terminate him because he can not come to the plant and we deal with him in very good way to keep him as company friend and avoid his bad behavior against the company . now he working with Islamic state and his brother prince in Islamic state) also I think in that moment he is liar and I didn't take any care for his news)

at 08:00 PM my wife sent to me her brother he was with her in quarry and she asked me to come to the quarry then I went to my family all of them cry and very worry because all the families leave the quarry I contacted with Mr mamdouh to ask Mr frederic for approve to evacuate my family to turkey .after I received previous news I can't go during any Islamic state check point .

at 11:00 PM I came back to the plant from quarry (no coverage signal in quarry) I saw son of the canteen contractor start loading all the food and every thing and collect all his team , He want to leave the plant and announced for all our employees in the plant he received sure news from Islamic state princes they will come to the plant also these news caused very big problem and worry to our team in the plant . I tried to convince him to stay .he agreed and stay till morning .

at 01:30 AM after midnight ali from PYD came to me with 3 military persons he told me the situation very bad and if there is any instruction from high management for the plant .he leave the plant also this caused strong worry in the plant for me and all our team .

at 05:00 I collected all our employees in the plant and I told him I will try to evacuate my family. also I received news during the night from HR specialist, PYD check point didn't allow the cars which we requested for evacuation to come to the plant .before I leave the plant I take car key from canteen contractor and give the key to our employees mohamd aljaseem he is forklift driver and car purchasing and mohamad morjan quality supervisor car (3 cars additional to my private car available in the plant 06:00 morning) then I evacuated with my family and my driver by my private car(now near the border in ean alarab)

also I appointed Eng ali haidar method manager as acting for me and I give him 2 radio one with him and one with morjan .

and I informed the guards supervisor all your instruction from ali haydar only .he is acting for me in the plant . I leave the quarry 07:00 with my family and my driver ten person and very little clothe by private car, in the road from plant to ean Alarab 30 KM no persons no animals no cars no sound only clashes sound and vibration all the people forced to leave to Ean alarab in that moment I discovered how much I am mistaken for my self and my family, if my car stop for any reason I will loss my life and my family .

I arrived to Ean Alarab Ali Haydar contacted with me and he told me ali PYD leader came to the plant and he asked all the employees to leave the plant immediately .I informed Mr Jean claude and Mr Ahmad jaloudy At 10:00 PM contractor aljasm from tall abiad contacted with me and he said the brothers from Islamic state they ask for your support and now I am in the plant with them, if you can send some one from Menbej to start the black start . then I answered him first tell them I am out side Syria and I am in leave and please tell them no body can start any equipment in the plant , all equipment's stop from France and only owner the plant can start . in the border and in turkey

when I reached to the border more than 5000 persons in the border and clashes between PYD and the people in the border the people broken the border gate in cordish side , Turkish side governor came and they closed ever thing from the Turkish side after that they told me take your family and back to your home .

then I search for nonlegal way many person from the plant area but they have good relation inside turkey and they inside turkey before one month the main problem was with my big family then they prepared ambulance and they came as human case then they put us in the ambulance car with doctors (as poisoning food family case) this process cost was 2000 \$ and 1000 TL for ambulance car and police and hospital and driver I put my car in Ean Alarab .

I went to Orfa for 2 days, I can't find apartment. the area full by cordish people from ean alarab, then I leave to Kilis and I stay two days with my brother then I leave with my family because his apartment very small only two rooms then I leave to gazy entab I meet with ahmad jalody and sorbolant he searched with me two days and we saw many areas the minimum price to rent apartment in suitable area (no problems between Turkish and Syrian people) 1500 \$ without furniture and I should pay money equal one month for guarantee and one month for landed office .then I leave to Alothmaniya city and since three days I searched for home and no school for my children in this city . I ask all of you to help me and advice me what I can do, and find some way to send to me 10000\$ to cover my expenses which not less than 500 \$/day included accommodation in very bad nonlegal pension in the far area one room and utilities only, and expenses the border till I find home with school in suitable area (no problem for Syrian people) I want to know if there is limit for budget for accommodation in turkey, sorbolant asked me many time for this then when I can not answer he leave me and he not answer my mobile also I ask your support with Ahmad jalowdy for my car near the border in Ean alarab . till today I can't find apartment with furniture.

please your quickly support I am with my family in the cold area with too much rain since four days rain continuously and to much cold for me and for my family . in the end I ask my company to applied same policy which I applied on my self and my family during more than two years to continue our plant and the business
